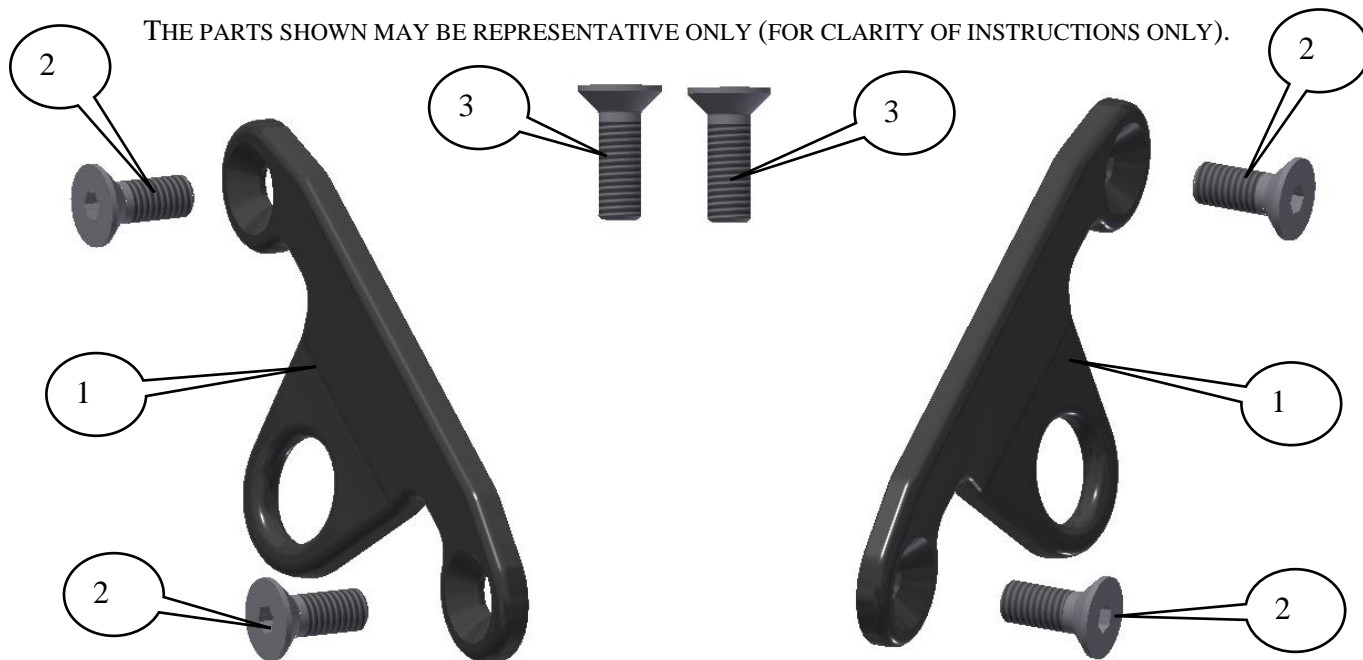

ITEM 3 = M8 x 25mm LONG COUNTERSUNK BOLTS (x2).

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!*

TOOLS REQUIRED

- Set of metric Allen keys to include 5 & 6mm A/F sizes.

GENERAL TORQUE SETTINGS

- M4 BOLT = 8Nm
M5 BOLT = 12Nm
M6 BOLT = 15Nm
M8 BOLT = 20Nm
M10 BOLT = 40Nm

FITTING INSTRUCTIONS

- Remove the OEM pillion footrests on both sides of the bike.
- Place two of the M8x20mm long countersunk bolts (item 2) through the holes in the transport hook (item 1).
- Offer the R&G tie-down hook into position and tighten into the thread on the subframe, as shown above.
- Repeat for the opposite side.
- Please note this product can be used on the right hand side in conjunction with R&G exhaust hanger (product code EH0047) fitted, using the two longer bolts supplied (item 3) as shown below.



- *Please ensure that when strapping the motorcycle down the ratchet straps do not come into contact with any part of the motorcycle, as the strap is likely to rub during transit and may cause damage.*
- We recommend that fabric from the straps be in contact with the product, as opposed to the hook on the end of the strap. This will increase the lifespan of the protective coating on the product.
- Do not overtighten straps attached to the product, as it would be possible to bend or break the product with excessive force. If in any doubt please consult a professional.

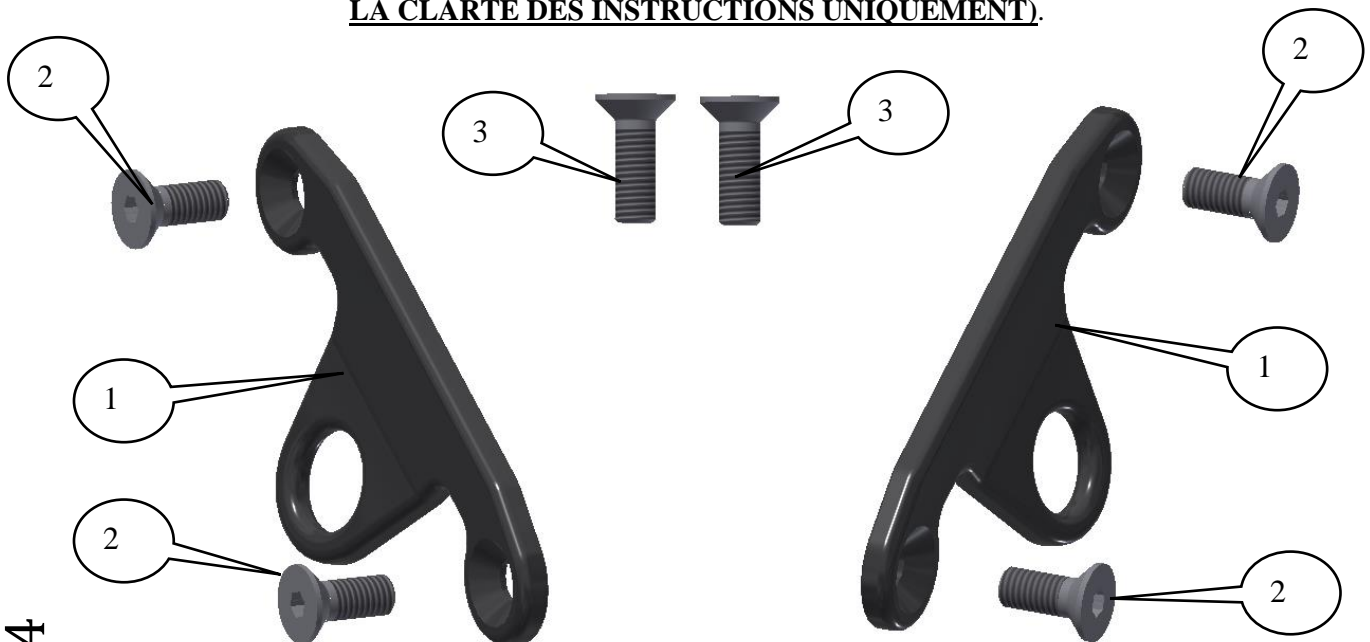
